Seller Responsibilities:

- Seller guarantees that the breeding is in accordance with the regulations of the Deutsch Langhaar Verband (**DLV**) and the Deutsch Langhaar Gruppe Nordamerica (**DL-GNA**). The Dog is a purebred dog, offspring of the sire and dam identified above
- Seller guarantees that all shots are current and deworming accomplished as necessary.
- Seller guarantees that the Dog is in good health and free of communicable diseases at the time of this sale. Buyer has seventy-two (72) hours from the purchase date to have the Dog examined by a licensed veterinarian, at Buyer's cost. If the Dog fails the examination, Buyer may return the Dog to the Seller, at Buyer's cost, for a full refund of the Purchase Price. The return must be accompanied by a written statement from the veterinarian.
- Seller guarantees that the Dog will be free of life-threatening or life-altering hereditary disease for the first twenty-four (24) months of age. If the Dog is found to have such a condition by a licensed veterinarian before the age of twenty-four (24) months, the Buyer is entitled to a full refund upon return of the Dog to the Seller. If the Buyer elects to retain the Dog, a fifty percent (50%) refund of the Purchase Price will be made upon proof that the Dog has been spayed or neutered. This health guarantee is non-transferrable if the Dog is sold or transferred to a new owner other than the Buyer.
- Seller agrees to accept the Dog back at any time during the Dog's lifetime if the Buyer wishes to relinquish ownership. No refund or replacement will be provided except under the terms of the health guarantee described above.

Buyer Responsibilities:

- Buyer guarantees that the Dog will be provided with compassionate care defined as routine veterinary care, warm and dry shelter, adequate containment, nutritional food, and routine contact with people and the outside world.
- Buyer guarantees that, should they ever decide to relinquish ownership of the Dog, the Seller must be notified immediately and given the first option to take the Dog back at Buyer's expense. At no time will this Dog be surrendered to a shelter or humane society.
- In the event that the Buyer sells the Dog to a new owner, Buyer shall ensure that the new owner agrees in writing with the terms of this Agreement.
- Buyer agrees that the Dog may only be bred in accordance with the DL-GNA and DLV regulations. The Dog is sold with a Limited Registration in the North American Versatile Hunting Dog Association, which will be lifted if/when the Dog is certified for breeding by the DL-GNA.
- Buyer agrees to make a best reasonable effort to test in the VJP Spring Puppy Test and have the Dog's hips evaluated in accordance with DL-GNA standards.

Indemnity and Release:

If any action or failure to act on the part of Buyer shall result in any claim, suit, loss, damage, injury, death, or liability, Buyer agrees to defend, indemnify, and hold Seller harmless and to pay all of Seller’s costs and expenses, including reasonable legal fees, any amount paid in settlement and any award or judgment with respect thereto. Buyer releases Seller from any and all liability, costs or damages caused by the Dog after placement with Seller, including but not limited to damage to or destruction of property, and injury to any person.

This Agreement represents the entire agreement between the parties. Seller and Buyer have made no other agreements, promises, representations or warranties, express or implied, unless specifically stated in this Agreement.
